Student [and Student's Parent or Guardian] expressly and completely assumes all risks of injury, death, or damage, however caused, resulting directly or indirectly from dance activities with Xiaopei Chinese Dance, Inc. and USCDA and /or use of equipment and facilities made available by Xiaopei Chinese Dance, Inc. and USCDA. PLEASE INITIAL TO SHOW YOU HAVE READ AND UNDERSTAND AND AGREE _____.

As consideration for being permitted by Xiaopei Chinese Dance, Inc. and USCDA to participate in dance activities, I hereby agree and warrant that I, my heirs, guardians, legal representatives, trustees, executors, and assigns will not make any claim against, sue, or prosecute any action or proceeding against Xiaopei Chinese Dance, Inc. and USCDA or any of its owners, shareholders, legal representatives, officers, employees, agents, successors, or assigns (collectively, the "Xiaopei Chinese Dance and USCDA Released Parties"), for any injury, death, or damage resulting directly or indirectly from Student's participation in dance activities and/or use of equipment and facilities made available by Xiaopei Chinese Dance, Inc. and USCDA, regardless of the cause of such injury, death, or damage. In addition, I hereby release and discharge the Xiaopei Chinese Dance and USCDA Released Parties from any and all actions, claims, or demands that Student, Student's heirs, guardians, legal representatives, trustees, executors, or assigns now have or hereafter may have for any injury, death, or damage resulting from Student's participation in any dance activity or use of equipment or facilities made available by Xiaopei Chinese Dance, Inc. and USCDA. PLEASE INITIAL TO SHOW YOU HAVE READ AND UNDERSTAND AND AGREE _____.

I AGREE AND WARRANT TO DEFEND, INDEMNIFY, AND HOLD HARMLESS THE XIAOPEI CHINESE DANCE and USCDA RELEASED PARTIES AGAINST ALL DAMAGES, CLAIMS, CAUSES OF ACTION, JUDGMENTS, COURT COSTS, EXPENSES AND ATTORNEYS' FEES WHICH ANY OF THE XIAOPEI CHINESE DANCE and USCDA RELEASED PARTIES MAY INCUR OR BE SUBJECT TO AS A DIRECT OR INDIRECT CONSEQUENCE OF STUDENT'S PARTICIPATION IN DANCE ACTIVITIES OR USE OF EQUIPMENT OR FACILITIES MADE AVAILABLE BY XIAOPEI CHINESE DANCE, INC. and USCDA. I AGREE THAT MY INDEMNIFICATION OBLIGATIONS ARE ENFORCEABLE AGAINST ME IN ACCORDANCE WITH THE EXPRESS TERMS AND SCOPE HEREOF, NOTWITHSTANDING ANY EXPRESS NEGLIGENCE RULE OR ANY SIMILAR PRINCIPLE THAT WOULD PROHIBIT OR LIMIT MY INDEMNIFICATION OBLIGATIONS BECAUSE OF THE SIMPLE OR GROSS NEGLIGENCE (WHETHER SOLE, CONCURRENT, ACTIVE, OR PASSIVE) OR OTHER FAULT OR LIABILITY OF ANY XIAOPEI CHINESE DANCE RELEASED PARTY. I SPECIFICALLY ACKNOWLEDGE AND AGREE THAT MY INDEMNIFICATION OBLIGATIONS RESULT IN THE COMPLETE INDEMNIFICATION OF THE XIAOPEI CHINESE DANCE RELEASED PARTIES EVEN IF SUCH A PARTY'S ORDINARY OR GROSS NEGLIGENCE (WHETHER SOLE, CONCURRENT, ACTIVE, OR PASSIVE) OR OTHER FAULT OR LIABILITY CAUSES OR CONTRIBUTES TO ANY DAMAGE, CLAIM, CAUSE OF ACTION, JUDGMENT, OR PROCEEDING TO WHICH THIS INDEMNIFICATION APPLIES. PLEASE INITIAL TO SHOW YOU HAVE READ AND UNDERSTAND AND AGREE _____.

It is my express intent that this Agreement bind Student and Student's heirs, guardians, legal representatives, trustees, executors and assigns. The terms of this Agreement shall be severable, such that if a court of competent jurisdiction holds any term to be illegal or unenforceable, the validity of the remaining portions of this Agreement shall not be affected thereby. I agree that this Agreement and any claim arising out of Student's participation in dance activities or use of equipment or facilities made available by Xiaopei Chinese Dance, Inc. and USCDA shall be construed in accordance with the laws of the State of California, without regard to such state's conflict of laws provisions.
